THAT PART OF LOT 14 IN EDELWEISS IN THE PARK SUBDIVISION, BEING A SUBDIVISION OF PART OF THE EAST HALF OF THE SOUTHEAST QUARTER OF SECTION 23, "OWNSHIP 37 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING WESTERLY OF THE FOLLOWING DESCRIBED LINE, SAID LINE BEING 81.89 FEET WESTERLY OF THE NORTHEAST CORNEX OF SAID LOT 14 (AS MEASURED ALONG THE NORTHERLY LINE OF SAID LOT 14) AND 79.73 FEET WESTERLY OF THE SOUTHEAST CORNER OF SAID LOT 14 (AS MEASURED ALONG THE SOUTHERLY LINE OF SAID LOT 14), IN COOK COUNTY, ILLINOIS.

To have and to hold the same, with the appurtenances, unto the Mertgagor and to the assigns of the Mortgagor, forever, freed and discharged of and from lien of said mortgage, and every part thereof; Provided, always nevertheless, that nothing herein contained shall in any way impair, alter or diminish the effect, lien or encumbrance of the aforesaid mortgage on the remaining part of the Mortgaged Premises, not hereby released therefrom, or any of the rights and remedies of the holder hereof which said mortgage shall remain in full force and effect for the balance of the Mortgaged Premises not hereby released.
