

ASSIGNMENT OF RENTS

SEE LEGAL DESCRIPTION ATTACHED HERETO AND MADE A PART HEREOF AS EXHIBIT "A"

hereby releasing and waiving all conds of any, of First Party under and by virtue of the Homestead Exemption Laws of the State of Illinois,

This assignment shall not become operative until a default exists in the payment of principal or interest or in the performance of the terms or conditions contained in the Mortgage herein referred to and in the Note secured thereby.

Without limitation of any of the legal rights of Second Party as the absolute assignee of the rents, issues, and profits of said real estate and premises above described, and by way of enumeration only, First Party hereby covenants and agrees that in the event of any default by the First Party under the said Mortgage above described, the First Party will, whether before or after the Note or Notes secured by said Mortgage is or are declared to be immediately due in accordance with the terms of the Mortgage, or whether before or after the institution of any legal proceedings: to foreclose the lien of said Mortgage, or before or after any sale farrein, forthwith, upon demand of Second Party, surrender to Second Party, and Second Party shall be entitled to take actual possession of, the said leal equal premises hereinabove described, or of any part thereof, personally or by its agents or attorneys, as for condition broken, and, in its discretion, nay with or without force and with or without process of law, and without any action on the part of the holder or holders of the indebtedness enumed by said Mortgage, enter upon, take and maintain possession of all or any part of said real estate and premises hereinabove described, together (vit) all documents, books, records, papers, and accounts of First Party relating therato, and may exclude the First Party, its agents, or servants, whonly theratrom, and may, in its own name, as assigned under this assignment, hold, operate, manage and control the said real estate and premises hereinglory described, and conduct the business thereof, either personally or by its agents, and may, at the expense of the mortgaged property, from time to time, either by purchase, rapair or construction make all necessary or proper repairs, renewals, replacements, useful alterations, additions, betterments, and improvements to the said real estate and premises as to it may seem judicious, and may insure and reinsure the same, and may lease said mortgage I property in such parcels and for such times and on such terms as to it may seem his, including leases for terms expiring beyond the maturity of the inflictedness secured by said Mortgage, and may cancel any lease or sublease for any cause or on any ground which would entitle the First Party to cincel the same, and in every such case the Second Party shall have the right to manage and operate the said real estate and premises, and to carry on the bilstress thereof, as it shall deem best, and the Second Party shall be entitled to collect and receive all earnings, revenues, rents, issues, profits, and incorrect the same, and any part thereof, and, after deducting the expenses of conducting the business thereof and of all maintenance, repairs, renewals, replezements, alterations, additions, betterments, and improvements, and all payments which may be made for takes, assessments, insurance, and prior or proper charges on the said real estate and premises, or any part thereof, including the just and reasonable compensation for the services of the Second Porty and of its attorneys, agents, clarks, servants, and others employed by it, properly engaged and employed, for services randered in connection with he operation, management, and control of the mortgaged property and the conduct of the business thereof, and such further sums as may be set icient to indemnify the Second Party against any liability, loss, or damage on account of any matter or thing done in good faith in pursuance of the rights and powers of Second Party hereunder, the Second Party may apply any and all monies arising as aforesaid

- (5) To the payment of the balance, if any, after the payment in full of the items hereinbefore referred to in (1), (2), (3) and (4) to the First Party.
