NOTICE OF LIEN

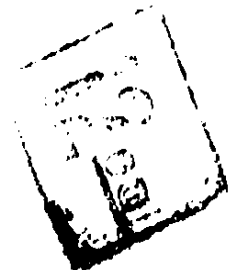
