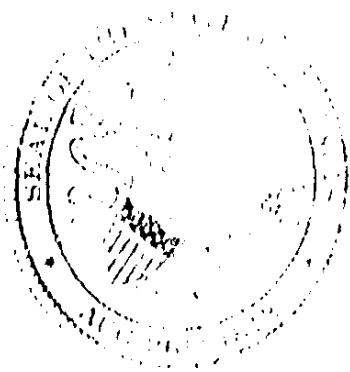

The registered agent cannot be the corporation itself. The registered agent may be an individual, resident in this State, or a domestic or foreign corporation, authorized to act as a registered agent.

NOTE: If a corporation acts as incorporator, the name of the corporation and the state of incorporation shall be shown and the execution shall be by its President or Vice-President and verified by him, and attested by its Secretary or an Assistant Secretary.
