

Excerpts From Internal Revenue Cod

Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount (including any interest, additional amount, addition to tax, or assessable penalty, together with any costs that may accrue in addition thereto) shall be a lien in favor of the United States upon all property and rights to property, whether real or personal, belonging to such person.

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the iten imposed by section 6321 shall arise at the time the assessment is made and shall continue until the liability for the amount so assessed (or a judgment against the taxpayor arising out of such (lability) is satisfied or becomes unenforceable by reason of lacse of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interester Mechanic's Lienors, And Judgment Lien Craditors. — The lien imposed by section 6321 shall not be valle as against any purchaser, holder of a security interest, michanic's lienor, or judgment lien creditor until notice thereof which meets the requirements of subsection (f) has been filed by the Secretary.

(f) Place For Filing Notice; Form.—

(1) Place For Filling - The notice referred to in subsection (a) shall be filed -

(A) Under State Laws

(ii) Real Property - in the case of real property, in one office within the State (or the county, or other gavernmental subdivision); as designated by the laws of such State, in which the property subject to the lien is situated; and

(iii) Personal Property - in the case of personal property, whether tengible or intangible, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State. In which the property subject to the flen is situated; at

(8) With Clerk Of District Court - In the office of the clerk of the United States district court for the judicial district in which the property subject to lien is situated, whenever the State has not by law designated one office which meets the requirements of subgaragraph (A), or

(C) With Recorder Of Deeds Of The District Of Columbia - In the office of the Recorder of Goods of the District of Columbia if the property subject to the lien is situated in the District of hie! Columbia:

(2) Situs Of Property Subject To Lien - For purposes of paragraphs (1) and (4), property shall be deemed to be situated -

(A) Real Property - in the case of real property, at its ohysical location; or

(B) Personal Property - In the case of personal property.

(p) Refiling Of Notice. - For purposes of this section -

(1) General Rule. — Unless notice of lien is refiled in the manner prescribed in paragraph (2) during the required refiling period, such notice of tien shall be treated as filed on the date on which it is filed (in accordance with subsection (f)) after the expiration of such reliling period.

(2) Place For Filing. — A notice of tien relied during the required retiting period shall be effective only -(A) If -

(i) such natice of lien is refiled in the office in which the prior notice of tien was filed, and

(ii) in the case of real property, the fact of reliling-isentered and recorded in an index to the extent required by subsection (f) (4), and

(3) Required Reflling Period. — in the case of any notice of lien, the larm "required refiling period" means-(A) the one-year period enting 30 days after the expiration of 6 years efter the date of the assessment of the tax, and (B) the one-year period ending with the expiration of 8 years after the close of the preceding required reliting period for such notice of tien.

Release Of 6325. Lien Or Sec. Discharge Of Property.

(a) Reisage Of Lien. - Subject to such regulations as the Secretary may prescribe, the Secretary shall issue a certificate of release of any lien imposed with respect to any internal revenue tax not later than 30 days after the day on which -

(1) Limbility Satisfied or Unenforceable - The Secretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has become legally unenforceable; or

(2) Bond Accepted - There is furnished to the Secretary and accounted by him a bond that is conditioned upon the payment of t'is amount assessed, together with all interest in respect thereof, which the time prescribed by law (including any extension of such time), and that is in accordance with such requirements of sung to terms, conditions, and form of the bond and suretibe Grecon, as may be specified by such regulations.

Sec. 6103. Confidentiality and Disclosure of Returns and Return la-... formation.

(h) Disclosure of Certain Returns and Return Information For Tax Administration Purposes. -

(2) Disclosure of amount of outstanding lien. - If a notice of lien has been filed pursuant to section 6323(f), the amount of the outstanding obligation secured by such lien may be disclosed to any person who fulfirshes satisfactory within evidence that he has a right in the property subject to such lien or intends to nbtain a right in such property. さい方けん
