Mortgagor convenants that Mortgagor is lawfully selzed of the estate hereby conveyed and has the right to mortgage, grant and convey the Premises, that the Premises is unencumbered unless otherwise acceptable to Mortgagee and the Mortgagor will warrant and defend generally the title to the Premises against all claims and demands.

#### IT IS FURTHER UNDERSTOOD THAT:

- I. Mortgagor shall promptly pay when due the principal of and interest on the indebtedness evidenced by the Note, and late charges as provided in the Note, and the principal of and interest on any future advances secured by this Mortgage.
