

SUPPLEMENT NO. 3 TO DECLARATION OF CONDOMINIUM OWNERSHIP FOR CARRIAGE HOMES OF WINDSONG CONDOMINIUM

This Supplement is made and entered into by American National Bank and Trust Company of Chicago, not individually, but as Trustee under Trust Agreement dated April 15, 1986 and known as Trust No. 67190 ("Trustee").

RECITALS

Trustee Recorded and Filed the Declaration of Condominium Ownership for Carriage Homes of Windsong Condominium (the "Condominium Declaration") on April 29, 1987 in the Office of the Recorder of Deeds for Cook County, Illinois as Document 87-229431 and filed with the Registrar of Torren's Title as Document LR3612036. (be Condominium Declaration submitted certain real estate to the provisions of the Condominium Property Act of the State of Illinois (the "Act").

In Article Mine of the Condominium Declaration, Trustee reserved the right and power to add any portion of the Development Area to the Condominium Property and subject such portion to the provisions of the Act and the Condominium Declaration. - 1. Terms. All terms used herein, if not otherwise defined herein, have the meanings set forth in the Condominium Declaration.
- 2. Added Property. The portions of the Development Area which are legally described and designated as Building Nos. 11, 12, 13, and 14 in the Third Amended and Restated Exhibit 3 to the Condominium Declaration, which are attached hereto, are beneby added to the Condominium Property and made subject to the provisions of the Act and the Condominium Declaration as "Added Property".
- 3. Amendment of Exhibit B. In order to reflect the addition of real estate to the Condominium Declaration. Exhibit B to the Condominium Declaration is hereby amended and restated to be as set forth in the Third Amended and Restated Exhibit B attached hereto.
- 4. The Added Dwelling Units/Amendment of Exhibit C. Exhibit C to the Condominium Declaration is hereby amended by adding to and making a part of Exhibit C Sheets 1A, 12, 13, 14 and 15 of Exhibit C which are attached hereto. Exhibit C, as hereby amended and supplemented, identifies each Added Dwelling Unit in the Added Property and assigns to it an identifying symbol.
