Parcel 1: Lot 16 in Blietz Connecticut Village, being a Subdivision of Part of the Northeast 1/4 of the Southeast 1/4 of Section 28, Township 42 North, Range 13, East of the Third Principal Meridian, according to the Plat thereof, recorded May 29, 1939 as Document 12,319,126, in Cook County, Illinois.

Parcel 2: That Part of the South 25 Acres of the Northeast Quarter of the Southeast Quarter of Section 28, Township 42 North, Range 13, East of the Third Principal Meridian, bounded and described as follows, to-wit: Commencing at a point in the Easterly Right of Way Line of the Chicago North Shore and Milwaukee Railway, which last mentioned Point is 129.0 feet Northwesterly of the South line of said Quarter Quarter Section, as Measured along said Easterly Right of Way Line (said last mentioned point being also the Southwesterly corner of Lot 16, in Blietz's Connecticut Village Subdivision); thence Southwesterly, at right angles to said Easterly Right of Way Line, 70 feet to a Point in the Joint Right of Way Line between the Chicago North Shore and Milwaukee Railway and the Chicago and North Western Railway Company; thence Northwesterly along said joint right of way line 55.0 Feet; thence Northeasterly, at Right Angles to the said Joint Right of Way Line, 70 Feet to a Point in the Easterly Right of Way Line of the Chicago North Shore and Milwaukee Railway which last mentioned point is also the Northwesterly Corner of Lot 16 in Blietz's Connecticut Village Subdivision; thence Southeasterly along the said Easterly Right of Way Line 55.0 Feet to the Place of Beginning, in the Village of Wilmette, Cook County, Illinois.
