Sec. 8321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses \$ pay the same after demand, the amount (including any interest, additional amount, addition to tax, or essessable penalty, her with any costs that may accrue in addition thereto, shall be a lien in favor of the United States upon all property and rights to property, whether real or personal, belonging to such person.

Sec. 6322, Period Of Lien.

Unless another date is specifically fixed by law, the lies imposed by section 6321 chall arise at the time the assessment is made and shall continue until the liability for the amount so seed (or a judgment against the texpayer arising out of such liability) is satisfied or becomes unenforceable by resson of lance of time.

Sec. 6323. Validity and Priority Against Certain Persons.

Purchaser's, Holders Of Security Inds, Mechanic's Lienors, And Judgment Lien Craditors. — The tien imposed by section 6321 shall not be railed as against any purchaser, holder of a security interest mechanic's linear as fudament. thereof-which meets the requirements of aubection (f) has been fled by the Secretary.
