THIS INDENTURE, made September 11 1987, between

James Auther Brown and Sarah L. Brown, his wife in Joint Tenancy herein referred to as "Mortgagors," and Security Pacific Finance Corp., an Illinois corporation, herein referred to as TRUSTEE, witnesseth:
