NOW, THEREFORE, Harris Trust and Savings bank, as Trustee under said First Mortgage, in consideration of the premises and of the sum of One Dollar (\$1.00) receipt whereof is hereby acknowledged, does hereby remise, release and quitclaim unto said Illinois Bell Telephone Company, its successors and assigns, all right, title and interest which said trustee may have acquired under and by virtue of said First Mortgage or under and by virtue of said Supplemental Indenture in and to the following described property, situated in the County of Cook, State of Illinois, and legally described on Exhibit A.


This release, however, shall not include or operate to release from the lien of the said First Mortgage or of said Supplemental Indentures any property other than that specifically described herein, all other property of said Illinois Bell Telephone Company, heretofore subjected to the lien of said First Mortgage and said Supplemental Indentures and not heretofore released by the undersigned Trustee, remaining subject to the lien of said First Mortgage dated January 15, 1941, and of said Supplemental Indenture as heretofore.


