SUBORDINATION AGREEMENT

THIS AGREEMENT made this 4th day of September 1987, by and between INLAND PROPERTY MANAGEMENT, INC., an Illinois corporation ("Property Manager"), and MASSACHUSETTS MUTUAL LIFE INSURANCE COMPANY, a Massachusetts corporation ("First Mortgagee"),

W I T N E S S E T H:

A. Pursuant to the terms and provisions of the Management Agreement dated as of June 1, 1984 between Property Manager and Shorewood Village Limited Partnership, an Illinois limited partnership ("Owner"), Property Manager has agreed to manage and operate certain property (the "Property") located at 9951-10081 Linda and 9946-10120 Holly, Des Plaines, Illinois, which is more particularly described in Exhibit A attached hereto and made a part hereof.

B. Owner is the sole beneficiary of the Illinois land trusts listed in Schedule A attached hereto. The trustees identified in Schedule A are hereinafter sometimes referred to as "the Trustees". Trustees are the owners of fee simple title to the Property. First Mortgagee, as a condition to making a loan to be secured by a first mortgage (the "Mortgage") on the Property, has required the execution of this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, to induce First Mortgagee to make a mortgage loan secured by the Property, and for other good and valuable consideration in hand paid, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby covenant and agree as follows:

1. Property Manager, for itself, its subcontractors, successors and assigns and all parties claiming by, through or under Property Manager, hereby subordinates any and all rights which Property Manager may have to a mechanic's lien on or against the Property to First Mortgagee's mortgage lien on the Property, which mortgage lien has been created by the Mortgage dated Sept 4, 1987, 1987, made by the Trustees to First Mortgagee and recorded in Cook County, Illinois as document number 87501248, and to any renewal, modification, substitution, extension or replacement thereof.

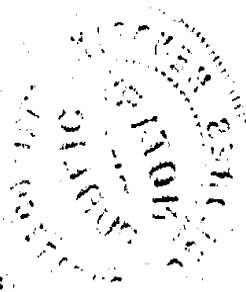
