This Supplement to Home Line Credit Mortgage is made this 21st day of August, 1987, between the Mortgagor, Michael P. Savoca and Wilhelmina L. 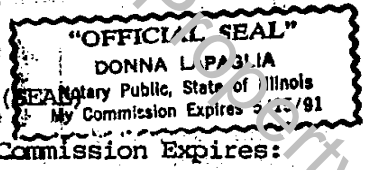

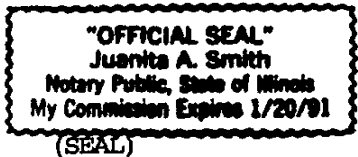
