ORDINANCE NO. 87-6-37

## AN ORDINANCE VACATING EVENHOUSE AVENUE

WHEREAS, the Board of Trustees of the Village of Rosemont has determined that the vacation of Evenhouse Avenue as depicted on Exhibit A attached hereto and made a part hereof is necessary, in the best interests of the Village and is within the spirit and purpose of the Rosemont Redevelopment Plan and Project.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ROSEMONT, COOK COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, as follows:

SECTION 1: That Evenhouse Avenue as depicted on Exhibit A attached hereto and made a part hereof be and the same is hereby vacated and closed inasmuch as said street is not required for public use and the public interest will be best subserved by such vacation and the Village President, Clerk and Engineer are authorized and directed to execute Exhibit A attached hereto and made a part hereof.

SECTION 2: This ordinance and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such ordinance should (a) contain terms contrary to the provisions of current or subsequent non-preemptive state law; or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the corporate authorities of the Village of Rosemont that to the extent that the terms of this ordinance should be inconsistent with any non-preemptive state law, that this ordinance should supersede state law in that regard within its jurisdiction.

SECTION 3: This ordinance shall be in full force and effect




