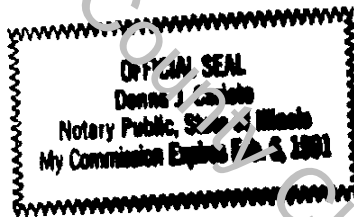

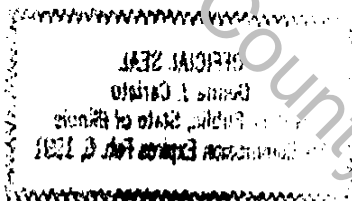

LEGAL DESCRIPTION

PARCEL 1:

THAT PART OF LOT 5 LYING SOUTHERLY OF ARCHER ROAD IN PLAT OF ESTATE OF GEORGE BEEBE, DECEASED, OF THE SOUTHWEST 1/4 OF SECTION 33, TOWNSHIP 38 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, EXCEPT THEREFROM THAT PART OF LOT 5 HERETOFORE CONVEYED TO VIOLA J. CRUMPACKER BY DOCUMENT RECORDED MAY 29, 1896 AS NUMBER 2395938 AND ALSO ALL OF SAID LOT 5 LYING EASTERLY OF A LINE BEGINNING AT THE NORTHWESTERLY CORNER OF THE LAND OWNED BY VIOLA J. CRUMPACKER BEGINNING ON THE SOUTHERLY LINE OF ARCHER ROAD, THENCE RUNNING SOUTHEASTERLY AND AT RIGHT ANGLES TO ARCHER ROAD TO A POINT OF INTERSECTION WITH THE SOUTH LINE OF SECTION 33 AFORESAID, BEING ALSO 87TH STREET PROJECTED, IN COOK COUNTY, ILLINOIS.

THAT PART OF LOT 5 IN THE WEST 1/2 OF THE SOUTHWEST 1/4 OF SECTION 33, TOWNSHIP 38 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN DESCRIBED AS FOLLOWS: BEGINNING AT THE SOUTHWEST CORNER OF SAID SECTION 33; THENCE NORTH ALONG THE WEST LINE OF SAID SECTION, 84.6 FEET TO THE CENTER LINE OF ARCHER ROAD; THENCE NORTHEASTERLY ALONG THE CENTER LINE OF SAID ROAD, 263.7 FEET FOR A POINT BEGINNING; THENCE CONTINUING NORTHEASTERLY ALONG SAID CENTER LINE OF SAID ROAD, 149.2 FEET TO THE EASTERLY LINE OF THAT PART OF SAID LOT 5 LYING SOUTH OF ARCHER ROAD; THENCE SOUTHEASTERLY ALONG SAID EASTERLY LINE OF SAID PART OF LOT 5 TO A POINT ON SAID LINE WHICH IS 160 FEET SOUTHEASTERLY OF, AT RIGHT ANGLES, FROM THE CENTER LINE OF ARCHER ROAD; THENCE SOUTHWESTERLY ALONG A LINE PARALLEL TO AND 160 FEET SOUTHEASTERLY OF THE CENTER LINE OF ARCHER ROAD AFORESAID, 128.56 FEET; THENCE NORTHWESTERLY ON A LINE AT RIGHT ANGLES TO SAID CENTER LINE OF ARCHER ROAD, 160 FEET TO THE POINT OF BEGINNING IN COOK COUNTY, ILLINOIS. ALSO KNOWN AS: VIOLA CRUMPACKER'S CONSOLIDATION OF PART OF LOT 5 IN THE WEST 1/2 OF THE SOUTHWEST 1/4 OF SECTION 33, TOWNSHIP 38 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT HEREOF RECORDED DECEMBER 10, 1932 AS DOCUMENT NUMBER 11181366, IN COOK COUNTY, ILLINOIS.

PARCEL 3:

THAT PART OF LOT 5 IN THE PLAT OF THE ESTATE OF GEORGE BEEBE, DECEASED, IN WEST 1/2 OF THE SOUTHWEST 1/4 OF SECTION 33, TOWNSHIP 38 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING SOUTH OF THE CENTER LINE OF ARCHER ROAD, LYING SOUTHERLY OF A LINE 160 FEET DISTANT AT RIGHT ANGLES TO THE CENTER LINE OF ARCHER ROAD AND EASTERLY OF A LINE BEGINNING AT A POINT IN THE CENTER LINE OF ARCHER ROAD, 263.7 FEET NORTHEASTERLY OF THE WEST LINE OF SECTION AND EXTENDING SOUTHEASTERLY AT RIGHT ANGLES TO THE CENTER LINE OF ARCHER ROAD, TO THE SOUTH LINE OF SECTION AFORESAID, IN COOK COUNTY, ILLINOIS.
