

GENERAL POWER OF ATTORNEY

- 1. I, MAKSIM LUNIC of 3708 South Kenilworth, Berwyn, Illinois 60402, hereby appoint SLOBODAN LUNIC, also of 3708 South Kenilworth, Berwyn, Illinois 60402, my true and lawful attorney in fact for me and in my name, place, and stead, and for my use and benefit:
- duty, or orligation whatsoever that I now have or may acquire the legal right, power, or capacity to exercise, do, or perform in connection with, arising out of, or relating to any person, item, or thing, transaction, business property, real or personal, tangible or intangible, or matter whatsoever;
- b. To appoint a substitute to perform any of the acts that my attorney is by this instrument authorized to perform, with the right to revoke such appointment of substitute at pleasure; to perform all acts necessary to be done in and about the premises as amply and fully to all intents and purposes as I could do if personally present;

To improve, repair, maintain, manage, insure, rent, lease, sell, release, convey, subject to liens, mortgage, and hypothecate, and in any way or manner deal with all or any part of any real or personal property, intangible and tangible, whatsoever, or any interest therein, which I now own or may hereafter acquire, for me and in my name, and under such terms and conditions, and under such covenants as such attorney shall deem proper;
- e. To engage in and transact any and all lawful business of whatever nature or kind for me and in my name; and
- f. To sign, indorse execute, acknowledge, deliver, receive, and possess such applications, contracts, agreements, options, covenants, deeds, conveyances, security agreements, bills of sale, leases, mortgages, assignments, insurance policies, bills of lading, warehouse receipts, documents of title, bills, bonds, debentures, checks, drafts, bills of exchange, notes, stock certificates, prexies, warrants, commercial paper, receipts, withdrawal receipts and deposit instruments relating to accounts or deposits in, or certificates of deposit of, banks, savings and loan or other institutions or associations, proofs of loss, evidences of debts, releases, and satisfaction of mortgages, liens, security agreements in writing of whatever kind and nature as may be necessary or proper in the exercise of the rights and powers herein granted.

I grant to our attorney in fact full power and authority to do and perform all and every act and thing whatsoever requisite, necessary, and proper to be done in the exercise of any of the rights and powers herein granted, as fully to all intents and purposes as I might or could do if personally present, with full power of substitution or revocation, hereby ratifying and confirming all that my attorney in fact, or his substitute or substitutes, shall lawfully do or cause to be done by virtue of this power of attorney and the rights and powers herein granted.
