WHEREAS, the Mortgage, as defined in the Assignment, has been amended by an instrument of even date herewith; and

WHEREAS, Assignor and Assignee desire that the Assignment be amended to include any of Assignor's interest in any leases affecting or pertaining to Parcel 5 as described on Schedule A;

NOW, THEREFORE, Assignor hereby agrees:

1. Schedule A attached hereto is hereby substituted as the new Schedule A to the Assignment;

2. Any reference to the Mortgage in the Assignment shall mean the Mortgage as defined in the Assignment, but as amended by the Amendment of Mortgage of even date herewith from LaSalle National Bank as trustee aforesaid as Mortgagor to Assignee as Mortgagee.

3. Except as otherwise specifically provided herein, all other terms, conditions and covenants of the Assignment remain in full force and effect.

This Supplement to Assignment of Lessors' Interests is executed by LA SALLE NATIONAL BANK, not personally but as trustee under the La Salle National Bank Trust No. 10-27044-09, in the exercise of the power and authority conferred upon and vested in it as such trustee, and, notwithstanding anything to the contrary contained in this supplement, it is expressly understood and agreed that nothing herein or in said note contained shall be construed
