

RELEASE DEED

THIS RELEASE DEED is made July 29th 19 87, by METROPOLITAN BANK AND TRUST COMPANY, an Illinois banking corporation ("the Bank"), 2201 West Cermak Road, Chicago, Illinois 60608.

WHEREAS, by a certain Trust Deed, dated February 25th, 19 85, and recorded in the Recorder's Office of Cook County, State of Illinois, in Book, Page, as Document No. 27477717, the premises situated in the County of Cook, State of Illinois, and more particularly described as follows:

The East 1/2 of the South 50 feet of that part of Block 9 lying South of the South line of Lots 17 and 18 in said Block 9 in S.J. Glover's Addition to Chicago, said addition being a Subdivision of all that part lying South of the South line of the Right of Way of the Chicago, Burlington and Quincy Railroad of the West 1/2 of the Northwest 1/4 of Section 26, Township 39 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois, and commonly known as 3800-12 West 26th Street, Chicago, Illinois. NOW, THEREFORE, the Bank, for and in consideration of the premises, and the sum of One Dollar, the receipt of which is hereby acknowledged, does hereby release the previously described real property from the lien created by the aforesaid Trust Deed and the other described instruments, and does hereby release, quitclaim and convey unto American National Bank & Trust Co. as t/u/t #56926 heirs, successors, legal representatives and assigns, whatever right, title, interest, claim or demand the Bank may have acquired in, through or by said Trust Deed and the other described instruments to the said property.

FOR THE PROTECTION OF THE OWNER, THIS RELEASE SHALL BE FILED WITH THE RECORDER OF DEEDS IN WHOSE OFFICE THE MORTGAGE OR TRUST DEED WAS FILED.

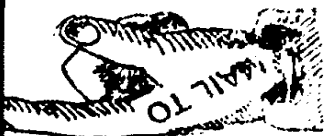
