AN ORDINANCE
ANNEXING CERTAIN TERRITORY
TO THE VILLAGE OF PALATINE
HAMPTON PLACE - RAND ROAD AND HICKS ROAD

WHEREAS, the Owners of record of the following de-
scribed territory have petitioned that said territory be
annexed to the Village of Palatine, Illinois, and

WHEREAS, the Municipal Authorities find and have
determined that said territory is contiguous to the Village
of Palatine, and

WHEREAS, the Palatine Rural Fire Protection District
and the Long Grove Fire Protection District have been duly
notified in writing more than ten (10) days in advance of
consideration of this ordinance, pursuant to statutes:

NOW, THEREFORE, BE IT ORDAINED, by the President and
Board of Trustees of the Village of Palatine, acting in the
exercise of their home rule power:

SECTION 1: That the following territory:

(See Legal Description attached as Exhibit "A")

and as shown on the plat of annexation attached hereto
and made a part of this ordinance, be and the same is hereby
annexed to the Village of Palatine.

SECTION 2: That upon passage of this ordinance, a copy
hereof, including the plat certified as correct by the
Village Clerk, be filed with the Recorder of Deeds of Cook
County, Illinois in accordance with the statute in such case
made and provided.

SECTION 3: That all ordinances or parts of ordinances
in conflict with this ordinance be and the same are hereby
repealed.

THE SOUTH 200.0 FEET OF THE EAST HALF OF LOT 1 IN THE NORTHWEST QUARTER OF SECTION 2, TOWNSHIP 42 NORTH, RANGE 10, EAST OF THE THIRD PRINCIPAL MERIDIAN, TOGETHER WITH ALL OF THE RIGHT OF WAY OF OLD HICKS ROAD AND RELOCATED HICKS ROAD (ILLINOIS ROUTE NO. 53) LYING EASTERLY OF AND ADJOINING SAID TRACT OF LAND, ALL IN COOK COUNTY, ILLINOIS


