WHEREAS, the Borrower is executing and delivering to the Assignee its Promissory Note dated as of even date herewith (such Promissory Note and any and all Notes issued in extension or renewal thereof or in substitution of replacement therefor being hereinafter referred to as the "Note") payable to order of the Assignee in the face principal amount of \$115,000 and expressed to mature on demand and expressed to bear interest prior to demand at the rate per annum (computed on the basis of a year of 360 days and actual days elapsed) determined by adding 2% to the prime commercial rate of the Assignee from time to time announced, such Note being issued in substitution and replacement for the Prior Note and to evidence the current unpaid principal balance of the Prior Note; and

WHEREAS, Assignor and Assignee desire to amend the Assignment to reflect the replacement of the Prior Note by the Note and to reflect other clarifications and modifications to the Assignment;

NOW, THEREFORE, for good and valuable consideration the receipt of which is hereby acknowledged, the Assignee and the Assignor hereby agree that the Assignment is amended as follows:

- 4. No reference to this Amendment need be made in any instrument of document at any time referring to the Assignment, any reference in any of such instrument or document to the Assignment to be deemed a reference to the Assignment as amended hereby.
