REPORT OF THE CHIEF OF POLICE, CHICAGO, ILLINOIS, ON THE MATTER OF THE INVESTIGATION OF THE ACTS OF VIOLENCE COMMITTED BY THE MEMBERS OF THE BLACK PANTHER PARTY AND OTHERS IN CHICAGO, ILLINOIS, ON OCTOBER 4, 1969.

On October 4, 1969, the Chicago Police Department received information that a group of individuals, including members of the Black Panther Party, had gathered at the intersection of State Street and Madison Street in Chicago, Illinois, and had engaged in acts of violence against the police and other individuals. The Chicago Police Department immediately dispatched officers to the scene and arrested several individuals.
