CANCELLATION OF LEASE

WHEREAS Austin Bank of Chicago as Trustee as aforesaid, is Successor Lessee under the Lease, and

WHEREAS Lessor and Lessee desire to cancel the Lease.

NOW THEREFORE in consideration of the foregoing premises, and other good and valuable consideration the Lessor and Lessee do hereby agree as follows:

1. CANCELLATION OF LEASE

The Lease described in the foregoing preambles is hereby cancelled and terminated, all effective as of the date of this Agreement.

2. TRUSTEE EXCULPATION

This instrument is executed by Austin Bank of Chicago, not personally but as Trustee as aforesaid, in the express of the power and authority conferred upon and vested in it as such Trustee, and under the express direction of the beneficiaries of a certain Trust Agreement dated February 22, 1983 and known as Trust Number 6133 to all provisions of which Trust Agreement this instrument is expressly made subject. It is expressly understood and agreed that nothing in this instrument contained shall be construed as creating any liability whatsoever against said Trustee or said beneficiaries, and in particular without limiting the generality of the foregoing, there shall be no personal liability to pay any indebtedness accruing hereunder or to perform any covenant, either express or implied, herein contained, to keep, preserve or sequester any property of said Trust, and that all personal liability of said Trustee (and said

beneficiaries to the extent permitted by law), of every sort, if any, is hereby expressly waived by Lessor, and by every person now or hereafter claiming any right or security hereunder, and that so far as the parties hereto are concerned the owner of any indebtedness or liability accruing hereunder shall look solely to the Trust Estate from time to time subject to the provisions of said Trust Agreement for the payment thereof. It is further understood and agreed that the said Trustee has no agents or employees, has no control over the real estate or the management thereof or the income therefrom and has no knowledge respecting rentals, leases or other factual matter with respect to said real estate, except as represented to it by the beneficiary or beneficiaries of said Trust.
