ORDINANCE NO. 87-40

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE  
CITY OF ROLLING MEADOWS, COOK COUNTY, ILLINOIS  
Fronte/East Side of Brockway, between Dupont and Emerson)

WHEREAS, a written Petition, under oath, signed by the owners of record of the land hereinafter legally described, has been filed with the City Clerk of the City of Rolling Meadows, requesting that said territory be annexed to the City of Rolling Meadows; and

WHEREAS, there are no electors residing on the territory; and

WHEREAS, said territory is not within the corporate boundaries of any municipality but is contiguous to the City of Rolling Meadows; and

WHEREAS, notice upon the Trustees of the Palatine Township Rural Fire Protection District has been served as required by the Illinois Revised Statutes; and

WHEREAS, the Palatine Township Commissioner of Highways and the Palatine Township Board of Trustees has been notified, in writing, of the proposed annexation of township highways, as required by the Illinois Revised Statutes; and

WHEREAS, the City Council is of the opinion that the annexation of said territory is in the best interests of the City;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROLLING MEADOWS, COOK COUNTY, ILLINOIS:

SECTION ONE: The territory legally described as follows is hereby annexed to the City of Rolling Meadows, Illinois, to-wit:

Lots 8, 9 and 10 in Block 31 in Arthur L. Heinemann and Company's Palatine Estates, Unit No. 3, being a Subdivision of Sections 26 and 27, Township 42 North, Range 10, East of the Third Principal Meridian, in Cook County, Illinois.

SECTION TWO: The Mayor of the City of Rolling Meadows is hereby directed to file in the Office of the Recorder of Deeds of Cook County, Illinois, a certified copy of this Ordinance, together with a correct map of the territory annexed.

SECTION THREE: The City Attorney is hereby directed to file in the Office of the Recorder of Deeds of Cook County, Illinois, an Affidavit that notice has been sent to all parties requiring notice of said annexation by the Illinois Revised Statutes.
