ORDINANCE NO. 87-40

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF ROLLING MEADOWS, COOK COUNTY, ILLINOIS Frantel/East Side of Brockway, between Dupont and Emerson)

WHEREAS, a written Petition, under oath, signed by the owners of record of the land hereinafter legally described, has been filed with the City Clerk of the City of Rolling Meadows, requesting that said territory be annexed to the City of Rolling Meadows; and
