IN THE OFFICE OF THE RECORDER OF DEEDS, Whereas the Village of Orland Park, Illinois, a municipal corporation, heretofore filed a Notice of Lien in its favor in the amount of \$ 2231.53 for unpaid water and sewer services on the following described real estate to wit:

THAT PART OF THE WEST HALF OF THE NORTHWEST QUARTER OF SECTION 10, TOWNSHIP 36 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTHWEST CORNER OF THE NORTHWEST QUARTER OF SAID SECTION 10; THENCE SOUTH ALONG THE WEST LINE OF SAID NORTHWEST QUARTER, 1666.70 FEET TO A POINT OF BEGINNING; THENCE EAST ALONG THE SOUTH LINE OF THE NORTH 1666.70 FEET, 726 FEET; THENCE NORTH 300 FEET TO A POINT WHICH IS 726 FEET EAST OF THE SAID WEST LINE OF THE NORTHWEST QUARTER; THENCE WEST ALONG A LINE PARALLEL TO AND 300 FEET NORTH OF THE SOUTH LINE OF THE NORTH 1666.70 FEET OF THE NORTHWEST QUARTER OF SAID SECTION 10, 726 FEET; THENCE SOUTH ALONG SAID WEST LINE A DISTANCE OF 300 FEET TO THE POINT OF BEGINNING, EXCEPT THAT PART HERETOFORE DEDICATED FOR LA GRANGE ROAD, ALL IN COOK COUNTY, ILLINOIS.
