## ATTACHMENT "A"

WHEREAS, on April 12, 1972, Lessor and Lessee entered into an Amendment amending said lease so as to provide that Lessor would carry its own fire and extended coverage insurance, said amendment being recorded as Document No. 21941383 in the office of the Recorder of Deeds of Cook County, Illinois; and
