AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN
REAL ESTATE TO THE VILLAGE OF ORLAND PARK, COOK
COUNTY, ILLINOIS (CALDERONE)

WHEREAS, there has been heretofore filed with the Village Clerk a Petition requesting annexation of the real estate hereinafter described to the Village of Orland Park, Cook County, Illinois; and

WHEREAS, said real estate is not now within the present corporate territorial limits of the Village of Orland Park, but is contiguous to and adjoining the present corporate territorial limits of the Village of Orland Park; and

WHEREAS, said real estate is not now within the present corporate territorial limits of any city, village or town; and

WHEREAS, there are no electors residing on said real estate; and

WHEREAS, it is to the best interests of the Village of Orland Park that said real estate be annexed to the Village of Orland Park in accordance with the provisions of the Statutes of Illinois in such case made and provided.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Orland Park, Cook County, Illinois, as follows:

SECTION 1

That the material allegations of the annexation Petition above-described heretofore filed with the Village Clerk are true and that said Petition states the matters required to be stated in accordance with the Statutes of Illinois in such case made and provided.

SECTION 2

A tract of land in the Southeast 1/4 of Section 14, Township 26 North, Range 12, East of the Third Principal Meridian, bounded and described as follows: Beginning at a point in the South line of said Southeast 1/4 of Section 14 that is 823.79 feet East of the Southwest corner of said Southeast 1/4 of Section 14, and running thence Northerly along a straight line whose Northern Terminus is a point in the North line of the South 1/2 of the Southeast 1/4 of Section aforesaid located 823.90 feet East of the West line of said Southeast 1/4 of Section 14, a distance of 481.19 feet; thence West along a line that is 481.19 feet North of and parallel with the South line of said Section 14, a distance of 328.83 feet; thence South along a straight line, a distance of 481.19 feet to a point on the South line of said Southeast 1/4 of Section 14; thence East along the said South line of Section 14, 328.83 feet to said point of beginning, all in Cook County, Illinois.


