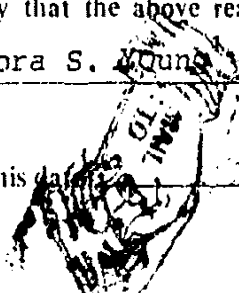
The statutory time for redemption of the above property has not yet expired.
