ORDINANCE NO. 87-0-37

AN ORDINANCE VACATING AN ALLEY IN THE VILLAGE OF WILMETTE, COOK COUNTY, ILLINOIS

WHEREAS, the President and Board of Trustees of the Village of Wilmette, Illinois, after due investigation and consideration, having determined that the alley hereinafter described is adjoined on both sides by private uses, has never been opened and will not be used by the general public as an alley and is no longer required for public use, and that the public interests will be subserved by vacating said parcel; and

WHEREAS, in the opinion of the President and Board of Trustees, the relief to the public from the further burden of responsibility and liability for said alley would be adequate compensation for the vacation of the alley hereinafter described;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Wilmette, Illinois:

SECTION 1: That the alley hereinafter described is no longer required for public use and the public interests will be subserved by vacating said alley.

SECTION 2: That the heretofore dedicated alley, legally described as

The North-South 20 ft. alley lying South of Washington Street and North of Central Avenue, between Lavergne Avenue and Laporte Avenue in Block 4 in the Second Addition to Wilmette-Laramie Subdivision, being a Subdivision of Lot 5 in County Clerk's Division of Section 31, Township 42 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois.

which said premises are shown on the attached plat, which plat

for greater certainty is made a part of this ordinance, BE AND THE SAME HEREBY IS VACATED AND CLOSED, as shown on said Plat of Vacation.

SECTION 3: A certified copy of this ordinance shall be filed by the Village Clerk of the Village of Wilmette, Illinois, for recording in the office of the Recorder of Deeds in Cook County, Illinois, within sixty days after passage of this ordinance.

SECTION 4: This ordinance shall be in full force and effect from and after its passage and approval, as required by law.
