

#### ORDINANCE NO. 87-0-036

### AN ORDINANCE ANNEXING PROPERTY (FIRST ADDITION TO POTTAWOTTAMI HIGHLANDS SUBDIVISION)

Be It Ordained by the President and Board of Trustees of the Village of Tinley Park, Cook and Will Counties, Illinois, as follows:

Section 1: That this President and Board of Trustees find as follows:

- (a) A recition has been filed with the Village Clerk and presented in proper form to the President and Board of Trustees of the Village of Tinley Park, requesting that the territory described in Section 2 of this Ordinance be annexed to the Village of Tinley Park, Cook and Will Counties, Illinois;
