

Sec. 6322. Period Of Lien.

Unless another data is specifically fixed by taw, the fleri Imposed by section 632f shall artsa at the time the assessment is made and shall continue until the liability for the amount so assessed for a judgment against the taxpayer arising out of such liability) is satisfied or becomes unenforceable by reason of lanse of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Creditors. — The tien imposed by section 6321 shall not be valid as against any purchaser, holder of a security Interest, mechanic's liener, or judgment lien creditor until notice thereof which meets the requirements of subsection (f) has been filed by the Secretary.

(n Place For Filing Notice; Form.-

(1) Place For Filing . The notice referred to in subsection (a) shall be filed .

(A) Under State Laws

(I) Real Property - in the days of real property, in one office within the State (or the county, or other governmental countries); as designated by the laws of such State, in which the property subject to the lien is situated; and

(ii) Personal Property - In the case of personal preparty, whether tangible or intangible, in one office. within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property aubject to the lien is situated;

(B) With Clerk Of District Court - In the office of the clerk of the United States district court for the judicial district in which the property subject to lien is situated, whenever the State has il not by law designated one office which meets the requirements of subparagraph (A), or

(C) With Recorder Of Deeds Of The District Of Columbia - In the affice of the Recorder of Deeds of the District of Columbia; if the property subject to the lien is situated in the District of Columbia. (155 in 1715

(g) Refilling Of Notice. — For purposes of this section

(1) General Rule. - Unless notice of iten is reliked in the manner prescribed in paragraph (2) during the required raffling period, such notice of lien shall be treated as filed on the date on which it is filled (in accordance with subsection (f)) after the expiration of such refiling period.

(2) Place For Filling. — A notice of tien retiled during the required retiling period shall be effective only.
