

AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP FOR NEWPORT CONDOMINIUM TO TRANSFER A GARAGE RIGHT

This agreement is made and entered into by and between Norman L. Bloch, guardian of the Estate of Margretta E. Plaut (hereinafter "seller") and Marian Sue Morris (hereinafter "buyer").

Whereas seller was appointed guardian of the Estate of Margretta F. Plaut in the cause pending in the Circuit Court of Cook County, # 87 P 1616; and

Seller, as quardian, desires to sell Margretta E. Plaut's interest in the non-exclusive garage right number 49, a limited common element, consisting of the right to park one (1) passenger automobile in the garage, which garage is delineated on the survey attached to the declaration of condominium ownership for the Newport Condominium, the declaration having been recorded in the Cook County Recorder's Office on November 21, 1978 as Document #24730609 (collectively hereinafter "garage right #49"); and

Article Two, Section 2.14 of the declaration permits the sale of a garage right between unit owners; and

Buyer owns Unit 410-S in the Newport Condominium and desires to purchase garage right #49; and

Any monies owed any entity holding a mortgage on garage right #49 have been paid.

Now, therefore, for consideration of Ten and no/100 (\$10.00) dollars, and other good consideration, receipt of which is hereby acknowledged:



IT IS HEREBY AGREED:

- 1. Seller, as guardian, hereby sells, transfers and conveys to buyer all of Margretta E. Plaut's right, title and interest in garage right #49 as more fully described above and on the legal description attached hereto;
- 2. This agreement shall be binding upon and shall inure to the benefit of the parties hereto, their successors and assigns and to any person having at any time any interest or estate in the property described above.
