That said owner is entitled to credits on account thereof as follows, to-wit: payments received 1/9/87 and 2/13/87 totaling \$4,200.00 plus \$100.00 for bedroom carpeting

leaving due, unpaid and owing to the claimant, after allowing all credits, the balance of Three-Thousand-Five-Hundred-Seventy-Two-and-47/100-Dollars, for which, with interest, the claimant claims a lien on said land and improvements.

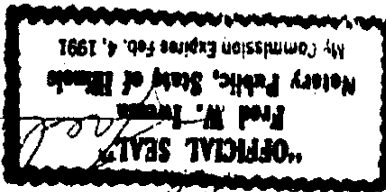
