or failing to meet, maintain, repair and other contributions of records, at any party makes
payment with a lease and party shall agree to pay any: Seining and Building Tax, and
in the event any judgment, fine or damages, at least amount of record, if any, and exhibit and
allowance of the court or magistrate, same.
