## AFFIDAVIT

1. On September 22, 1987 an Order was entered by the Honorable Henry A. Budzinski in the matter of the Estate of Jane Elizabeth Green, a/k/a Elizabeth C. 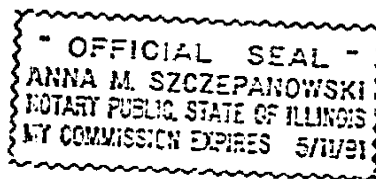

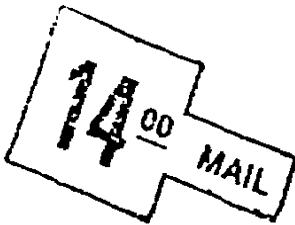
