1. That she is the duly elected Village Clerk of the Village of Wheeling, located in the Counties of Cook and Lake, State of Illinois.

That she served notice upon each of the Trustees of the Wheeling Township Fire Protection District by enclosing in an envelope a typewritten letter addressed to each of said Trustees notifying said Trustees that the President and Board of Trustees would consider the annexation of the real property described below, at a public meeting of the President and Board of Trustees to be held on the 5th day of October, 1987.
