PARTIAL RELEASE DEED

KNOW ALL MEN BY THESE PRESENTS, that Harris Trust and Savings Bank, an Illinois banking corporation, in consideration of one dollar, and other good and valuable consideration, the receipt whereof is hereby acknowledged, does hereby release to Harris Trust and Savings Bank, as Trustee under Trust Agreement dated May 21, 1985 and known as Trust Number L-1042-111, the eight, 111th, Interest, claim or demand whatsoever it may have against me, through or by that certain Mortgage and Security Agreement with Assignment of Rent dated December 20, 1985 and recorded December 20, 1985 as Document No. 85-19211 (the "Mortgage") in the premises described below, situated in the County of Cook, State of Illinois, as follows:

A portion of town and country's Brothers Credit Subdivision located at approximately in the Southeast 1/4 of the Northwest corner of Section 11, Township 41 North, Range 10, East of the Union Pacific Railroad in Cook County, Illinois and more particularly described on the attached Exhibit "A".

I, do expressly understand and agree that this release is in no way to operate to discharge the lien of Harris Trust and Savings Bank, upon any part of the premises described in the Mortgage, but is only to release the portion particularly above described and none other; and that the release of any unleased portions of the premises in said Mortgage described are to remain as security for the payment of the indebtedness to me, to my heirs and for the full performance of all the covenants, conditions and obligations contained in said Mortgage and the same remain unaltered.
