PARTIAL RELEASE DEED

KNOW ALL MEN BY THESE PRESENTS, that Harris Trust and Savings Bank, an Illinois banking corporation, in consideration of one dollar, and other good and valuable consideration, the receipt whereof is hereby acknowledged, doth hereby release to Harris Trust and Savings Bank, at Houston and Dearborn Apartments, 33rd Street, Chicago, Illinois, all rights, title, interest, claim or demand whatsoever it may have against me, through or by said certain Mortgage and Deed of Trust Agreement with A.S.S. Ginent of Kenosha dated December 26, 1985 and recorded December 27, 1985, as Document No. 85-196211 (the "Mortgage") in the premises described below, situated in the County of Cook, State of Illinois, as follows, to-wit:

A portion of Town and Country's Weatherfield Subdivision being a subdivision in the Southeast 1/4 of the Northwest 1/4 of Section 4, Township 41 North, Range 10, East of the third Platline Meridian in Cook County, Illinois, and more particularly described on the attached exhibit "A".


