that the best way to judge the quality of a model is to compare it with the observed data. This is done by calculating the coefficient of correlation between the observed data and the data predicted by the model. The coefficient of correlation is a measure of how well the model fits the observed data. It ranges from -1 to +1, where -1 indicates a perfect negative correlation and +1 indicates a perfect positive correlation. A value of 0 indicates no correlation.
