A parcel of land in the East one-half of Section 5, Township 38 North, Range 14 East of the THird PM comprised of a part of Lot 6, part of Lot 8 both in the Stockyards Subdivision in the East one-half of Section 5, Township 38 North, Range 14 described as follows:

Beginning on the West line of the East 40 ft of the East one-half of Section 5, at the point which is 2649.88 ft North from the south line of the East one-half of Section 5, and running thence North along the West line of the East 40 ft, a distance of 878.12 ft to an intersection of the South line of W. Exchange Avenue, (said point of intersection being 3528.0 ft, measured along the west line, north from the point of intersection of the west line of the East 40.0 ft with the south line of the East one-half of Section 5), thence west along said south line of W. Exchange Avenue of said south line being a line perpendicular to the West line of the East 40.0 ft a distance of 317.66 ft, thence south along the line parallel with the east line of the East one-half of Section 5, a distance of 6.0 ft, thence west along the line perpendicular to the last described course, a distance of 284.83 ft, thence westerly along the straight line (a westerly terminus of which is a point 3511.34 ft North from the South line and 701.86 ft west from the east line of said east one-half of Section 5), a distance 35.365 ft to an intersection with the arc of a circle convex to the West and having a radius of 3425.87ft with extends southwardly from a point which is 3521.0 ft north from the south line and 6771.18 ft west from the east line of the East one-half of Section 5 to a point 3361.54 ft north from the south line and 681.06 ft. west from the East line of the East one-half of Section 5, thence southwardly along the arc of said circle, a distance of 153.57 ft to

said point which is 3361.54 ft north from the south line 681.06 ft west of the east line of the East one-half of Section 5, thence southwardly along a straight line a distance of 712.54 ft to a point 2649.0 ft north of the south line of the East one-half of Section 5, thence east along a straight line a distance of 339.35 ft to a point 2646.27 ft north from the south line and 342.50 ft west on the East line of the East one-half of Section 5, thence north along the line parallel with the East line of the East one-half of Section 5, a distance 2.26 ft to a point 2648.53 ft north of the south line of the east one-half of Section 5, thence east along the straight line a distance 302.50 ft to the point of beginning.
