MEMORANDUM OF AGREEMENT

THIS MEMORANDUM OF AGREEMENT is made and entered into this ADD day of ADDD 1987, by and between GREGORY BEELER and AMBER BEELER, husband and wife residing at 1 Thorwood, Flossmoor, Illinois 60422 (collectively the "BEELERS"), and MARATHON PETROLEUM COMPANY, an Ohio corporation with offices at 539 South Main Street, Findlay, Ohio 45840 ("MARATHON");

whereas, the BEELERS and MARATHON, among others, are parties to an Improvement Agreement wherein they agreed to place of record a product restriction applicable to the property located at 2733 Flossmoor Road, City of Flossmoor, Cook County, Illinois more particularly described as follows:

This restriction is a covenant running with the land and shall be included in any and all instruments affecting the title of the property.
