THE COVENANTS, CONDITIONS, PROVISIONS AND ASSIGNMENT OF RENTS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS MORTGAGE):

- 1. Mortgagor shall keep the improvements on the Property insured against any loss or damage occasioned by fire, extended coverage perils and such other hazards as Mortgagee may require, through insurers approved by Mortgagee, in amounts not less than the unpaid balance of the Indebtedness plus any other indebtedness secured by the Property, without co-insurance. The policies shall contain the standard mortgage clause in favor of Mortgagee and, unless Mortgagee otherwise agrees in writing, the original or, if this is not a first mortgage, a certificate or memorendum copy of all policies covering the Property shall be deposited with Mortgagee. Mortgagor shell promptly give notice of loss to insurance companies and Mortgagee. If this is a first mortgage, Mortgagee may adjust or compromise any claim and all proceeds from such insurance shell be applied, at Mortgage's option, to the installments of the improvements on the Property.

 2. Mortgegor covenents: to keep the Property free from other liens and encumbrances superior to the lien of this mortgege; to pay all superior liens or encumbrances as they fall due; to keep the Property in good and tenantable condition and repair, and to metore or replace damaged or destroyed improvements and fixtures; not to commit waste or permit waste to be committed upon the Property; not to remove, demolish or materially siter any part of the Property without Mortgegee's prior written consent, except Mortgegor may remove a fixture, provided the fixture is promptly replaced with another fixture of at least equal utility; to comply with all laws, ordinances, and regulations affecting the Property, to permit Mortgegee and its authorized representatives to enter the Property at reasonable times to inspect it and at Mortgegee's option, repair or restore it; if this is a first mortgege, to pay Mortgegee sufficient funds at such times as Mortgegee designates, to pay the estimated annual real estate taxes and assessments on the Property and all property insurance premiums (hereinafter "Escrow"), but, if not designated to be paid to Escrow, to pay before they become delinquent all taxes, assessments and other charges which may be levied or assessed against the Property, and to pay the property insurance premiums when due. Upon Mortgegor's failure to perform any duty herein, Mortgegee may, at its option and without notice, perform such duty, including without limitation paying any amount and the cost of such performance shall be due on demand and secured by this mortgege, bearing interest from date incurred until date paid at the lower of the annual percentage rate disclosed on the note of even date herewith or the highest rate allowed by law. No interest will be paid on funds held in Escrow and they may be committed with Mortgegee's general funds.

Mortgages, Athout notice, and without regard to the consideration, if any, paid therefor, and notwithstanding the existence at that time of any it for or liens thereon, may release any part of the Property or any person liable for any indebtedness secured hereby, without in any way affecting the liability of any party to the Indebtedness and mortgage and without in any way affecting the priority of the lien of this morter ga, to the full extent of the indebtedness remaining unpeid hereunder, upon any part of the security not expressly released, and may agrie with any party obligated on the Indebtedness or having any interest in the security described herein to extend the time for payment of the indebtedness secured hereby. Such agreement shall not, in any way, release or impair the lien hereof, but shall extend the lien hereof as against the title of all parties having any interest in said security which interest is subject to
- 4. Upon default by Mortgegor in any term of an instrument evidencing part or all of the Indebtedness; upon Mortgegor or a surety for any of the Indebtedness degrin; to exist, becoming insolvent or a subject of benkruptcy or other insolvency proceedings; or upon breach by Mortgegor of any coverien; or other provision herein, all the Indebtedness shall at Mortgegoe's option be accelerated and become immediately due and payaller, Mortgegoe shall have all lawful remedies, including foreclosure, but failure to exercise any amendy shall not weive it and all immedies shall be cumulative rather than alternative; and in any suit to foreclose the lien hereof or enforce any other remedy of Mortgegoe under this mortgego or any instrument evidencing part or all of the Indebtedness, there shall be allowed and included as additional indebt oness in the degree for sale or other judgment or degree, all expenditures and expenses which may be paid or incurred by or on befull of Mortgegoe, including but not limited to attorney's and title fees.
- 5. Mortgagee may waive any default without whiving any other subsequent or prior default by Mortgager. Upon the commencement or during the pendency of an action to (preciose this mortgage, or enforce any other remedies of Mortgagee under it, without regard to the adequacy of the Property as security the court may appoint a receiver of the Property (including homestead interest) without bond, and may empower the receiver to take possession of the Property and collect the rents, issues and profits of the Property and exercises such other powers as the court may grant until the confirmation of sale, and may order the rents, issues and profits, when so collected, to be held and applied to far court may direct. Invalidity or unenforceability of any provision of this mortgage shall not affect the validity or enforceability of the provision. The covenants and agreements of all Mortgagors are joint and several. This mortgage benefits Mortgagee, its juccentors and assigns, and binds Mortgagor(s) and their respective heirs, executors, administrators, successors and assigns.

- 6. If all or any part of the Property or either a legal or equitable interest therein is sold or transferred by Mortgagor without Mortgagoe's prior written consent, excluding transfers by devise or dracint or by operation of law upon the death of a joint tenant or a partner or by the grant of a leasehold interest in a part of the Property of three years or less not containing an option to purchase, Mortgagoe may, at Mortgagoe's option, declare all sums accured by Yils Mortgago immediately due and payable to the extent allowed by less and the note(s) hereunder and any failure to exercise said option, rickling constitute a weiver of the right to exercise the same at any other time.
- 7. Assignment of Rents. To further secure the indebtedness, Mortgagor dries hereby sell, assign and transfer unto the Mortgagoe all the rents, issues and profits now due and which may hereefter become dur mider or by virtue of any lease, whether written or orditor any letting of, or of any agreement for the use or occupancy of the Property or any part thereof, which may have been heretofore or may be hereafter made or agreed to, it being the intention hereby to establish an also be transfer and assignment of all of such leases and agreements unto Mortgagoe, and Mortgagor does hereby appoint insvocatily Mortgagoe its true and lawful attorney (with or without taking possession of the Property) to rent, lease or let all or any portion of the Property to any party at such rental and upon such terms as Mortgagoe shall, in its discretion determine, and to collect all of said rents, issues and profits arising from or accruing at any time hereafter, and all now due or that may hereafter become due.

Mortgagor represents and agrees that no rent has been or will be paid by any person in possession of any portion of the Property for more than one installment in advance and that the payment of none of the rents to accrus for any portion of the said Property has been or will be weived, released, reduced, discounted or otherwise discharged or compromised by the Mortgagor. Mortgagor waives any right of set off against any person in possession of any portion of the Property. Mortgagor to ses not to further assign any of the rents or profits of the Property.

Nothing herein contained shall be construed as constituting the Mortgagee a mortgagee in possession in the absence of the taking of actual possession of the Property by the Mortgagee. In the exercise of the powers herein granted Mortgagee, no itability shall be asserted or enforced against Mortgagee, all such liability being expressly waived and released by Mortgage.

Mortgagor further agrees to assign and transfer to Mortgagee by separate written instrument all future learer upon all or any part of the Property and to execute and deliver, at the request of the Mortgagee, all such further assurances and astignments as Mortgagee shall from time to time require.
