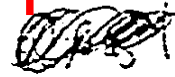

## SUBCONTRACTOR'S CLAIM FOR LIEN

The undersigned Claimant, F & K CONTRACTORS, INC., of 1425 Kings Road, of the City of Carpentersville, County of Kane, State of Illinois, makes the following statement and claims a mechanic's lien under the law entitled "An Act to Review the Laws in Relation to Mechanic's liens" approved May 18, 1903 and all amendments thereto, and states:

1. The real property known and described as follows on July 27, 1987, was owned by the BANK OF RAVENSWOOD, TRUSTEE OF TRUST NUMBER 25-86-39 and by virtue of Deed dated 9/23/87 and recorded 10/15/87 the following real estate is now owned by MARIO J. TROFA, 1718 North Bissell, Chicago, IL 60614

BORNSTEIN & COMPANY, INC., a corporation, as an original contractor for the furnishing and supplying of materials, services, labor, work and fixtures for the construction of a building and other improvements on the above described premises; on or before July 27, 1987, the original contractor made a contract with INTERNATIONAL CONSTRUCTION COMPANY, a corporation, to perform certain labor, furnish materials, services, labor, work and fixtures, for the construction of a building and other improvements on the above described premises; on or before July 27, 1987, INTERNATIONAL CONSTRUCTION COMPANY, a corporation, made a contract with the Claimant to furnish drywall, installation of drywall and taping of drywall for said work and in the improvement of the above described premises for a total value of Two Thousand Eight Hundred forty-five and 13/100's-----(\$2,845.13)----- which is the fair, usual, customary, and reasonable value of such

materials, equipment, supplies, labor and services. Claimant has furnished such services and material to the extent required by the contract, all of which were furnished and delivered to and used in and about the improvement of the premises and of the building and other improvements thereon. The last of said materials, fixtures, work, labor and services so furnished as a subcontractor were furnished on or about August 28, 1987.

3. There is now justly due and owing to the Claimant for the furnishing, delivery, or performance of such materials, supplies, equipment, labor and services aforesaid by Claimant the sum of \$ 2,845.15 , which is still due and unpaid. Notice has been given to the Owner and Contractor in the manner provided by law not less than 10 days prior hereto.

4. Claimant now claims a lien upon the above described premises and all improvements thereon against all persons interested and also claims a lien upon the monies or other consideration due from the aforesaid owner to the original contractor for the amount of \$ 2,845.15 , together with interest as provided by statute.

5. Notice has been duly given to the owner, and persons otherwise interested in the above described real estate, as to the status of the undersigned as subcontractor as provided by Section 24 of Chapter 82 of the Illinois Revised Statutes.
