That Section 4 of Chapter 98 of the 1971 Illinois Municipal Code of the Village of Dolton provides that after proper notice if the owner or occupant of any premises on which weeds or plants are permitted to grow in violation of provisions of Chapter 98 as aforesaid, refuses to cut said weeds or plants, the Village of Dolton may proceed to do so and that the expenses shall be charged and paid by such owner or occupant.

That on May 28, 1987, the owners of the above described property were notified in writing in accordance with the above mentioned ordinance provisions, but that said owners neglected and/or refused to cut the weeds.

That on June 28, 1987, the VILLAGE OF DOLTON caused said weeds to be cut, removed and destroyed, and the reasonable cost and expense incurred for the work was ONE HUNDRED AND NO/100 (\$100.00), and that said sum remains unpaid.

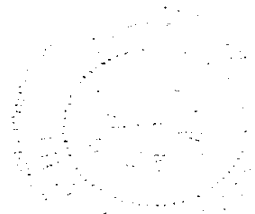
