That on July 6 1987, the owners of the above described property were notified in writing in accordance with the above mentioned ordinance provisions, but that said owner neglected and/or refused to cut the weeds.

That on July 16, 1987, the Village of Dolton caused said weeds to be cut, removed and destroyed and the reasonable cost and expense incurred for the work was ONE HUNDRED AND NO/100 (\$100.00) and that said sum remains unpaid.

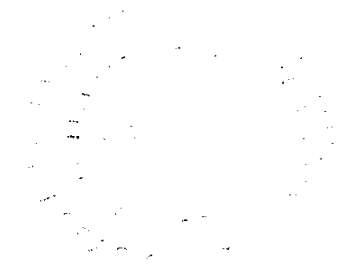
