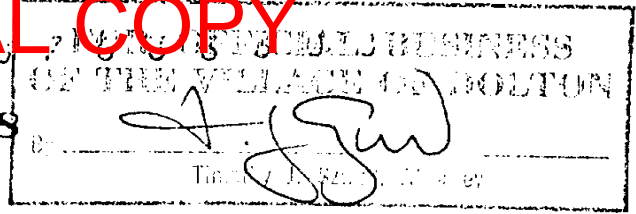

NOTICE OF LIEN

The Lien Creditor, VILLAGE OF DOLTON, an Illinois municipal corporation, pursuant to the provisions of Section 11-20-7 of the Illinois Municipal Code (Chapter 24, Illinois Revised Statutes), hereby files notice of lien in its favor in the amount of TWENTY-FIVE AND NO/100 (\$25.00) against the following described real estate:

Lot 35 & 36 in Charles H. Brandt sub. of part of the SE 1/4 of Sec. 3-36-14, commonly known as Greenwood & Irving, Dolton, Illinois 60419.

That Section 4 of Chapter 98 of the 1971 Illinois Municipal Code of the Village of Dolton provides that after proper notice if the owner or occupant of any premises on which weeds or plants are permitted to grow in violation of any provisions of Chapter 98 as aforesaid, refuses to cut said weeds or plants, the Village of Dolton may proceed to do so and that the expenses shall be charged and paid by such owner or occupant.

That on August 6, 1987, the owners of the above described property were notified in writing in accordance with the above mentioned ordinance provisions, but that said owners neglected and/or refused to cut the weeds.

That on August 17, 1987, the VILLAGE OF DOLTON caused said weeds to be cut, removed and destroyed, and the reasonable cost and expense incurred for the work was TWENTY-FIVE AND NO/100 (\$25.00), and that said sum remains unpaid.
