That on August 17, 1987, the VILLAGE OF DOLTON caused said weeds to be cut, removed and destroyed, and the reasonable cost and expense incurred for the work was ONE HUNDRED AND NO/100 (\$100.00) and that said sum remains unpaid.

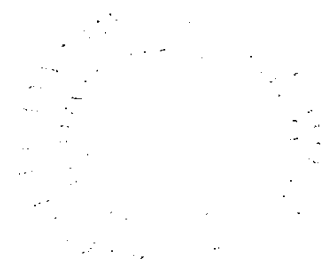
