MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE, dated as of NOVEMBER 7, 1987, by and between ORLAND PARK JOINT VENTURE, an Indiana General Partnership (hereinafter called "Landlord"), and JERRICO, INC., a Kentucky Corporation (hereinafter called "Tenant"):

WITNESSETH:

That by lease (hereinafter called "the Lease") dated September 1, 1987, Landlord has demised and leased to Tenant, and Tenant has leased from Landlord, for a term commencing upon the "Commencement Date" (as defined in the Lease) and, unless extended or sooner terminated under the provisions thereof, continuing therafter until the expiration of the twentieth (20th) "Lease Year" (as defined in the Lease), a certain parcel of property comprising part of the Lake View Plaza Shopping Center, which such parcel is legally described in Exhibit "A" attached hereto and hereby made a part hereof.
