MEMORANDUM OF AGREEMENT

THIS MEMORANDUM OF AGREEMENT (this "Memorandum") is made as of this 25th day of November, 1987 by and between American National Bank and Trust Company of Chicago, a national banking association, as Trustee under Trust Agreement dated October 25, 1984, and known as Trust Number 62600 ("Trustee"), PLB/TDC Limited Partnership, an Illinois limited partnership ("Beneficiary", and Trustee and Beneficiary being hereinafter referred to collectively as "Seller") and Balcor Real Estate Finance Inc., an Illinois corporation (hereinafter referred to as "Buyer").

WITNEBBETH:

- 1. The Seller, an optioner, and the Buyer, as optionee, have this day entered into that certain Option Agreement (the "Agreement"), wherein Seller has granted to Buyer an irrevocable right and option (the "Option") to elect to purchase the Property (as defined in the Agreement), which Property is located upon and includes the real estate legally described in Exhibit A attached hereto and made a part hereof.
- 2. The Buyer may exercise the Option by giving Seller Written notice of Buyer's election to exarcise the Option to purchase the Property at any time during the Option Period, as hereinafter defined.
- 3. The Option Poriod is defined as the period commencing January 2, 1988 and expiring January 15, 1988, both dates inclusive, subject, however, to Buyer's right to extend the Option in accordance with this Agreement.
- 4. The Agreement sets forth additional terms and provisions with respect to the purchase of the Property.
