AN ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE VILLAGE OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS

WHEREAS, a written petition, signed by the legal owners of record of all land within the territory hereinafter described, has been filed with the Village Clerk of the Village of Willow Springs, Cook County, Illinois, requesting that said territory be annexed to the Village of Willow Springs, and
